National News



NATIONAL SECRETARY/TREASURER-Brenda Anderson

NEW By-Law Books are available from the National Office. They cost \$5.50, and includes postage; you can use PayPal or a Court Check to order. EVERY court needs a minimum of two copies, one for the Regent and Vice-Regent; but it is highly recommended that every officer have a copy.

Program Idea-Go through the Local section at your meetings, one area at each meeting to 'educate' your members on the by-laws we are following. Everyone needs to know what is going on and what the bylaws actually say.

Writing a By-law – Often the Bylaws are misunderstood and we feel there should be changes made. NOW is the time to review the current (2024 bylaws) and take action to make changes if you, your court and your State Court adopts. Any bylaw change, addition, or deletion can have a starting point from the Campus, Local, and State Courts as well as from a State Board or National bylaw committee. These are all called Bylaw amendments.

WHAT TO DO:

- LOOK at the bylaws, and discuss these. The bylaw form asks for the rational (or reason) why you feel this change needs to be made. The form to use is in the "Tools of the Trade", Section 4 (State), attachment 23 or page number 4-62.
- If a bylaw amendment is desired then it must first be passed at the Local or Campus level and presented at the STATE convention to be considered, discussed, voted on, and adopted prior to submitting by Jan 15, 2026 for the next National Convention in 2026 in Iowa. This gives every member a voice.
- A State Court may also write an amendment, but it must be written and voted on by the State Board, and then submitted to National by the deadlines provided.
- NOW is the Time for everyone to have a voice. A good bylaw is one that keeps the same rules at all levels for consistency. A good bylaw will make conducting CDA business easier as direction is given. Good bylaws make our Order stronger and more organized. ALL bylaw amendments submitted to the National Bylaw committee will be considered, but may not be brought forward to the Convention floor for discussion; however, the sponsor of the bylaw has an option to bring it to the National convention floor for discussion.

DEADLINES for submission of bylaw amendments to your State Regent for presentation at the State Convention will be used. ALL adopted amendments will be sent to National bylaw committee.

ALL Approved amendments must be signed, by the State Regent and State Secretary or by the Local Regent and Recording Secretary. Local courts need to send a copy of the amendments proposed with the rationale to the State Regent. Five (5) copies of each amendment shall be sent to the State Bylaws Chair with one amendment per page.

Second Place: St. Katharine Drexel #2516 of Bowdle-Roscoe-Hosmer, SD for their THINK prayer cards. They handed out the THINK prayer cards in their parishes suggesting that the prayer "Eternal rest grant unto them O Lord and let the perpetual light shine upon them. May the souls of the faithful departed through the Mercy of God rest in peace. Amen" be said whenever a THINK sign was spotted on our highways.

Third Place: Our Lady of Lourdes #2056, Hot Springs, SD for the placement of a stained glass window of Jesus kneeling "In the Agony in the Garden" put into a beautiful wooden frame which was placed on the front door of their church inside a cross opening.

An Unexpected Miracle of Mary's Presence

Testimony following the 53rd Biennial South Dakota Catholic Daughters Convention- April Larson, St. Ann Court #1121

Immediately returning to Pierre from the SDCDA Convention - an experience that moved me deeply and opened my heart in ways I'm still reflecting on - I stopped at the grocery store to pick up flowers. I wanted to thank our Court Regent for her leadership and care, and I made sure to include red roses - Mother Mary's flower.

As I walked back to my car, bouquet in hand, I glanced down and felt my heart stop. The small image of Mary, the centerpiece of my gold ring stamped "Italy," had fallen out. I had been wearing it almost daily for the past 3 months as a reminder of her healing love, her presence in my life, and my desire to grow closer to her. And now, during this sacred weekend... it was gone.

But something extraordinary happened. Rather than feeling sorrow or panic, I felt calm. On the drive back from Spearfish, I had been listening to a powerful podcast episode by Fr. Chris Alar titled "Mary: The Gift of Mercy." He spoke of her tenderness, her nearness, and how she intercedes for us in quiet, profound ways. And at the convention, we had been blessed by the words of a Sister who spoke with such wisdom about Mary's grace and her faithful presence.

Losing that image of Mary from my ring, right after that weekend of prayer, fellowship, and devotion - while I was holding roses for someone who had guided our Court in love - did not feel like a loss at all. It felt like a message. A gentle whisper: "I'm not just on your finger. I am with you. I walk with you. I am here, in your day-to-day, in your gratitude, in your giving."

When I arrived home, another quiet miracle greeted me. As I approached the elevator in my building, the door opened - without me pressing the button, and with no one else in sight. It felt like another tender confirmation: "You're not alone. You are home. You belong."

The weekend was filled with powerful testimonies, personal awakenings, and messages I will continue to pray over. But perhaps the clearest sign I received came not through grand gestures, but through the smallest things: the loss of a ring, the choosing of a rose, an elevator door opening. Each moment a whisper of Mary's loving presence.

Thank you to all who made the convention possible. I pray that we may all continue to recognize Mary's gentle miracles in our own lives - and share them, to strengthen the faith of others..


Seven stained glass windows that show the history of the Carmelite order will illuminate the new sacred space. These price-less windows were rescued from St. Clara Catholic Church in Chicago, the former provincial church for the Calced Carmelites in America and Shrine of St. Therese, after a fire nearly destroyed them.

The interiors will be simple and prayerful, in keeping with Carmelite spirituality, but well-proportioned with ample light and warm, natural materials. The new monastery choir will be attached to the chapel with the customary Carmelite grille in place to protect the Sisters' enclosure and privacy. The Sisters will use the choir to participate each day in the Mass and to pray the Divine Office and two hours of mental prayer required by their Holy Rule.

The Monastery is autonomous and receives no financial support from the Diocese or the Order. They depend entirely on donations from supporters like you.
