The 53rd Biennial Convention of the South Dakota State Catholic Daughters of the Americas® was called to order by State Regent Judy Konechne on Friday, April 11, 2025, at 10:00 am at the Holiday Inn Convention Centre in Spearfish, SD.

Reverend Fr. Jim Friedrich, State Chaplain, led an Opening Prayer.

The Color Guard presented the colors. All joined in reciting the Pledge of Allegiance led by Michele Sage, 1st Vice Regent and singing the first stanza of the National Anthem led by Nicole Fuhrer. Second Vice State Regent, JoAnn Hoffman and State Secretary, Mary Kay Zimmerman led the singing of the Opening Ode.

Rev. Jim Friedrich blessed the convention Marian floor shrine.

Regent, Judy Konechne introduced those seated at the head table. She also recognized and thanked the Past State Regents in attendance.

There is always good news and bad news in the membership report. We started two new courts since the last convention. We welcome Court Our Lady of Wisdom #2799 on the SDSU campus in Brookings and Court Our Lady of the Black Hills #2805 in Piedmont to their first convention. We welcomed 45 new members in those two courts. We will try to start a few more this next year. But we would really like to work on gaining new members in each court. If you look at the membership totals in the program booklet, we added almost 200 members, which is fabulous. We had 12 courts who increased their membership while losing a few members. We recognize five courts today.

Court Joan of Arc #846 in Milbank increased their membership by 16 %.

Court Sancta Maria # 368 Dell Rapids increased their membership by 11%.

Court St. James #2757 Chamberlain increased their membership by 8%.

Court Our Lady of the Rosary #2560, Dakota Dunes increased their membership by 7.5%.

Court Margaret Mary #2453 Mitchell increased their membership by 6%.

We award these courts a certificate of excellence. Congratulations to these courts. Let's take a moment to ask these Excellence award winners to share the secrets of growing membership.



OH, BUT we lost 233 members, that is 36 more members than we gained. That is 12% of our total membership. We lost 93 ladies to death, which we will honor at the memorial Mass today. We had 105 members resign their membership and 29 forfeited their membership. Are we asking those ladies why they are leaving? Don't leave new membership to the officers of your courts, or to the membership Chair. She needs your help. Membership starts with all of us. We would like to focus on welcoming new members into our courts for the next two years. Watch for information on a Membership Challenge in the next newsletter. It may be hard to keep asking women to join, but we learned some great talking points yesterday. Remember as women and mothers we go through many stages in our lives. Just because it didn't work 2 years ago, that same woman may be looking to deepen her faith today. Keep asking. Be respectful of their no, but be persistent. Have you asked 70 times 7 times?? We are all called to be disciples of Christ and spread our faith. Look around at Mass in your parish. It seems that so many of the faithful are either members of Catholic Daughters or Knights of Columbus. Think of those who are teaching religion to the youth. Many of those are also CDA members. And what would be better than turning a "Christer" family into a family that never misses Mass. Think of how that multiplies from mother to entire families. We are much older than the speakers from yesterday, happily in our 70's. But I know that we need the young women to join and fearlessly lead us into THIS century. They are knowledgeable about how to accomplish the mission of Catholic Daughters in a better, more efficient way. We need to let them take the reins of our courts, support their new ideas, and be their biggest cheerleaders. If we only did things the way we always did, we would still be in corsets and using a horse and buggy to get around, like they did when the Catholic Daughters were instituted in 1903! As Brenda will say: "Let's take a bite out of that elephant". As Judy says "Open your Heart to God's Love and Listen to Him".

State Regent, Judy Konechne reconvened the business meeting at 1:38pm.

She asked all the newly nominated members for the Nominating Committee to come forward and be recognized. The nominees were given a moment to introduce themselves.

## ***RESOLUTIONS & BY-LAWS***

*Mary Althoff, Court St. Patricia #271, Sioux Falls, Chair*

Mary Althoff stated the committee had not received any proposed resolutions and only one by-law change for discussion or review. The by-law change was received from Court Our Lady of Wisdom #279, Brookings, SD as follows:

Article XIV Campus Court  
Section 2. Officers

Current Wording:

- B. Nominations for court officers are made from the floor at the first business meeting of the fall semester.
- C. Elections are conducted by voice vote or ballot at the first meeting of the fall semester.

Proposed Change:

- B. Nominations for court officers are made **during the campus school year, in either the spring or fall semester, when the court deems fit.**
- C. Elections are conducted by voice vote or ballot, **one business meeting after nominations are made.**

Rationale: This allows more flexibility for campus courts to hold elections at a time that works for them and ultimately what's best for the court. With Courts across the country, there are various school schedules and expectations at the start of a new semester.

A motion was made by Mary Althoff, Court St. Patricia #271, Sioux Falls to pass this by-law change. A second was received. A vote was taken and it passed. This will be submitted to the National Convention for consideration.

## ***STATE ABUSE PROJECT***

*Carol Kling, Court Immaculate Heart of Mary #2654, Lemmon, State Chair*

The State Courts in South Dakota have raised \$20,703.23 since our last convention. A check was presented to Grant Sasse of Catholic Social Services of the Rapid City Diocese for half of the proceeds. The same amount will be divided between abuse projects in the Sioux Falls Diocese.

The goal of the Lifesavers Abuse Project is to raise money to be used exclusively for abuse victims. But our secondary goal is to educate the public about what is happening around them.

I want to recognize 2 courts that went over and above in this area.

- Court Holy Heart #163 of Woonsocket, population of only 648, held a sausage pizza breakfast and raised \$570.

- Court St. Rita #534 of Watertown is awarded for their innovation by creating a poster that they hung around their community. Their success in raising \$2,683.30 is attributed to early announcements from their priest to the congregation giving information as to where the funds will be used and instructions to “bring your purses and wallets filled with cash to give to the victims of abuse”. Another key was that they prayed the Rosary for victims as they stuffed the baggies with LifeSavers and information. The last key, it was in their bulletin for 3 weeks prior to their project.

Carol reminded courts to participate by giving a minimum of \$50 to this project, even if a fundraiser is not held.

State Regent Judy Konechne presented The Bishop’s Burse, in the amount of \$10,351.62 to Bishop Scott Bullock of the Rapid City Diocese. The same amount will be given to Bishop Donald DeGrood of the Sioux Falls Diocese.

## ***SATURDAY, APRIL 15, 2023***

Prior to the business meeting, Fr. Jim Friedrich, State Chaplain, led Morning Meditation and Prayers. Father invited all to visit the adoration chapel, anytime throughout convention.

The meeting was reconvened at 8:18am am by State Regent Judy Konechne. Delegates were seated for voting and the doors were secured for voting.

State Secretary Mary Kay Zimmerman called Roll.

Following Roll Call, State Secretary Mary Kay Zimmerman and the Credentials Committee were excused to confirm the report.

The Opening Ode was sung.

While awaiting the credentials report, the State Regent shared information regarding a donation made from Lifesavers Against Abuse at the last convention. The Lourdes Center from the Sioux Falls Diocese returned the donation given to them, as they did not feel they served the mission meant for the donation. The State Board will research abuse shelters in the diocese and disburse the donation among them.

State Regent Judy Konechne called for the Credentials Report.

Mother Teresa #2510, Sioux Falls; and Elsie Baye, Ct St. Thomas #1533, Humbolt. The Review Committee found the books of both the State Secretary and State Treasurer in good order.

Motion was made by Patricia to accept the Financial Review. Motion carried.

## **STATE MILITARY**

Joy reported that funds from 2023 Charitable Contributions were distributed to the VA in Ft Meade for a Peace/Healing Garden for hospice patients \$1,485.42. She continued to share that there are around 1400 homeless people in the Sioux Falls area on any single night, and in Rapid City approx. 1500, of which over 15% are veterans. The Barakah House in Sioux Falls, has a bedding for emergency situations specifically for homeless veterans. These veterans are not just in need of housing, but they have an opportunity to continue on with the project and take communication classes and learn how to interact with people in a social setting. Most importantly, they help find jobs and basic life skills, such as Conflict Resolution that they may have lost while they were out in the field; serving our country. I myself am a graduate from the Barakah House. With the partnership of the Veterans Administration, I received the much needed social and communication skills that I have to use today. I have gone on to be able to secure housing, fall in love with the man of my dreams, and marry all within the past 8 years. I propose that we donate \$1800 to the Barakah House, so that they continue the mission of no veteran to ever be homeless.

## ***CIRCLE OF LOVE - LEADERSHIP***

The following awards were announced.

First place: Court Madonna, #1952, Plankinton

Project: St. John's Centennial Celebration

Summary: St. John's was in need of volunteers to plan its centennial celebration. Court Madonna Regent Mary Mayclin put a call out for volunteers who would be interested in planning the event. Fourteen people attended the first planning meeting in June 2024, including nine CDA members. The 14 broke into committees that would plan the decorations, history, invitations, publicity, program, hospitality and reception for the estimated 300 guests including Bishop DeGrood, Fr. Richard Fox and Fr. Randy Phillips. The September 2024 celebration included mass, a meal, musical selections, memories from parishioners, and recognition of the youngest and oldest members of the parish. Decorations included display boards illustrating the history of the parish and information about the stained-glass windows.

Second place: Court St. Rose of Lima, #700, Wagner

Project: Joy for JCDA

Summary: The Court wanted to revive its JCDA program, which had been at a standstill since Covid. The group held a sign-up meeting in March 2024. A lot of religious education students attended the meeting, and seven joined JCDA at that event with five more joining later. Since that time, the JCDA members have created a video about the Eucharist and the proper way to receive communion, completed a cemetery project for prayers for the deceased, compiled a list of nuns in South Dakota for whom to pray, made rosaries for children, held a play and pray event, created prayer books, and held a Saint Wax Museum

event and Walk for Life event. Two CDA members are the JCDA leaders, but the leaders also include three other mothers who have volunteered to provide food or supplies for the meetings. Other CDA members also provide support where needed.

Third place: Court Saint Patrick, #1699, Kimball

Project: Summer VBS Wilderness Adventure

Summary: The Court and its members wanted to offer children an opportunity to continue their religious education with a weeklong summer Vacation Bible School. "Wilderness Adventure" took 48 children through the seven sacraments. About 15 CDA members participated as coordinators, teachers, snack coordinators, decorators, game leaders, craft coordinators and music coordinators. Daily activities included a daily virtue demonstration, a skit, a visit from a member who played the part of a saint, lessons, and music, crafts and snacks that coordinated with the day's featured sacrament. For instance, the snack for Holy Orders was to make fishing poles out of pretzels, rope licorice and gummy fish to represent our priests as "fishers of men." There were about 10-15 religious education students from grades 7-12 served as student helpers.

Honorable Mention: Court Our Lady of Lourdes, #2056, Hot Springs

Project: Being Informed Matters

Summary: The Court sent two delegates to the National Convention in New Orleans despite initial concerns that doing so would be too expensive for the Court to afford. Members decided that they would benefit from having representatives at the convention because those representatives could share all they had learned at the convention upon their return. The Court's goal was to continue to grow in Unity and Charity. The national convention would help them do that because it's a time for learning, sharing and networking with other CDA Courts. To help get their delegates to New Orleans, the Court gave each delegate \$600 to help defray costs. They held fundraisers (including a fall rummage sale) to help. The delegates brought back ideas and were also able to vote on key issues such as new national leadership boards, by-laws and new dress standards for officers as the use of robes is discontinued.

## ***NATIONAL REPRESENTATIVE MESSAGE***

### **Be a Beacon of Hope, A Light in the Darkness**

Good afternoon! It is an honor and a privilege to attend the South Dakota State Convention. I bring each of you greetings from our National Regent Susan Moné, our 28th National Regent and members of the entire board. I congratulate you on your 53rd Biennial State Convention. Your theme, "Open Your Heart to God's Love and Listen to Him", is most fitting based on your agenda. I see you plan to demonstrate and reflect on your theme through all the activities planned for this convention.

Let's make sure at our meetings, we pray the Rosary or schedule a spiritual activity, meetings are scheduled with an agenda and are started on time, have members to share ideals, when speaking, speak clearly, create a Court Calendar, celebrate special moments, acknowledge all members and keep members engaged. One most important recruiting method is to have a regular meeting and open it to all interested women. It is also important to have a local membership team in place.

If you have not done so, please review the Membership Survey results obtained from our members. The survey can be found in the Fall 2024 issue of the SHARE Magazine and on our CDA Website. Our main goal should be to retain the members we already have as well as to recruit new members. We must agree that members' expectations are different and changing daily. Remember, if some form of communication or action is not taken members will lose interest in CDA. So do not wait and see. Let us take the guess work out of engagement and retention and give all members the content they need and crave. Just think, there is no better way to do this than to Be a Beacon of Hope, A light in the Darkness. Remember, when a member leaves, they do not leave the organization, they leave the members.
